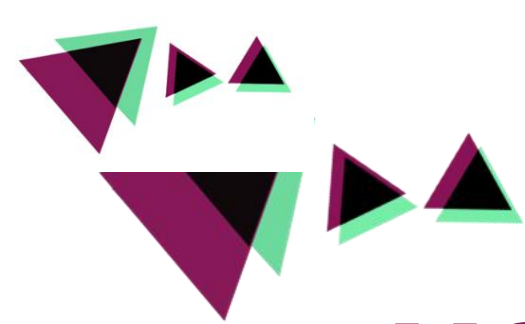

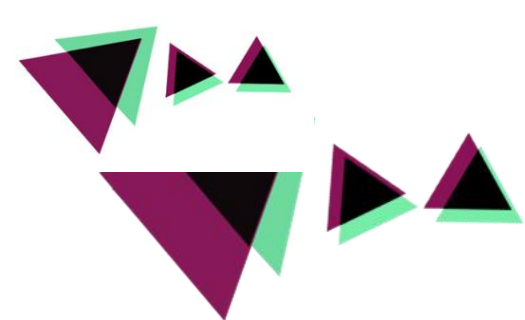

Where to look for advice? National Contact Points (NCPs)

Core functions

❖ Informing and awareness raising

- Circulate general and specific documentation on the HE MSCA
- Organise information and promotional activities
- Raise awareness of HE MSCA funding opportunities to relevant national stakeholders from the scientific community, industry and public authorities

❖ Assisting, advising and training

- Assist researchers and organisations, in particular new actors and SMEs, with a view to increasing and improving their participation in Horizon Europe
- Assist in partner search activities
- Advise on administrative procedures, rules and issues (i.e. European Charter for Researchers, ethical requirements)

Note: As the NCPs are national structures, the type and level of services offered may differ from country to country.
